RECORDING NEW ADDRESS ON DRIVER'S LICENCE

If you wish to have the new residential address recorded on your driver's licence, please present the licence with this advice at any Customer Service Centre.

The change of name and/or address details provided by you will be used to update the records relating to any motor vehicle registered by you (as an operator or owner) or driver licence or learner's permit held by you under the Motor Vehicles Act 1959 and any vessel registered by you or boat operator licence or special permit held by you under the Harbors and Navigation Act 1993.

CHANGE OF NAME

Before a change of name can be processed you will need to supply evidence of a change of name **AND** a document that provides a link between the current and previous name(s). If you are the holder of a driver's licence/learner's permit/proof of age card, a replacement will be necessary (prescribed fee applies).

GARAGING ADDRESS - vehicles only

If the garaging address of your vehicle is different to your residential address or if you have changed the garaging address of your vehicle, the appropriate section on the front of this form must be completed. In order to determine a vehicle's garaging address the Registration Authority may require the production of one or more of the following relating to the relevant premises:

- > Certificate of Title
- > Lease or Rental Agreement (current)
- > Taxation Assessment Notice in relation to the premises (last or current year)
- > Council Rate Notice (current)
- > Utility Accounts relating to the street address (Gas, Electricity, Phone, Water)

Where the residential address and the garaging address are identical, the Registration Authority may waive the requirement to produce the above documentation if it is satisfied, as a result of other or previous evidence, that the residential address is the vehicle garaging address.

South Australian registered vehicles cannot be registered with an Interstate garaging address.

CHANGE OF GARAGING ADDRESS / PREMIUM CLASS - vehicles only

If you have CHANGED THE GARAGING ADDRESS FOR YOUR VEHICLE and the INSURANCE DISTRICT HAS CHANGED FROM INSURANCE RATING DISTRICT 1 TO INSURANCE RATING DISTRICT 2 OR VICE VERSA, a separate 'NOTIFICATION OF PREMIUM CLASS' must be completed.

Your insurance rating is based on the address where the vehicle is garaged. Your insurance premium class is determined by reference to the CTP Regulator's website at www.ctp.sa.gov.au that best fits your vehicle.
