



### WHAT THIS FORM IS USED FOR

This application form is for an immediate family member of a primary producer who requires a higher class of licence to drive a family farm vehicle to transport produce to a silo or other destination but due to age or driving experience, does not qualify for the appropriate licence class. Information provided on this form will be considered by the Service SA Customer Service Centre Manager before making a decision.

### WHAT APPLICANTS WILL NEED

The applicant must be aged 18 years or over and must have held a class C driver's licence for 12 months.

If this application is being submitted in person, the applicant will be required to show proof of identity.

### READ THIS INFORMATION FIRST

- The applicant must complete section 1 of this form, the primary producer must complete section 2 and both must sign the relevant declaration overleaf.
- The Registrar of Motor Vehicles has the authority to grant a restricted licence to applicants who require such a licence for the purposes outlined above. The class of learner's permit issued will depend on the vehicle/s owned by the primary producer named on this form. The licence issued may be class HR or HC, depending on the size of vehicle/s **owned by the primary producer named on this form.** The Registrar may place conditions on any driver's licence issued.

**NOTE** If the practical driving test is conducted by an Authorised/Accredited instructor, the applicant can apply to have the licence restrictions removed after 12 months. If the practical driving test is conducted by a Police Officer in remote areas, the removal of the restriction will require the applicant to be re-tested by an Authorised/Accredited Instructor after 12 months of holding the restricted licence.
